

Dear Parents,

Subject : School Fees for 2<sup>nd</sup> and 1<sup>st</sup> Quarters of Session 2020-21

Say we must that COVID-19 has brought us closer to the Parents who are one of the most important constituents of the Academy, next only to our Students. We are here again to address you on School Fees even though the streaks of unlocking slowly gain prominence.

It has been our objective since the inception to try in our own possible ways to mitigate the hardship befalling some of our Parents under the scourge of the pandemic.

In the 1<sup>st</sup> Quarter we therefore not only slashed the collectible amount of items payable at a time into only one-fourth in each Quarter, the *rate of Fees* for the Quarter was also diminished to the old ones prevailing in the earlier session 2019-20, dates of payment extended repeatedly keeping all Fines in strict abeyance. We had to take a large part of the resultant stress on our ourselves, but succeeded in enabling many or most of the Parents to reciprocate in the way much essential to keep operative a private, unaided educational institution not falling the least in its zealous mission. But the others are also equally nested in our mind. In fact in the backdrop of difficulties persisting in some way or other, the Management of your Academy has once again decided to stretch itself as much as possible, and even much more, to curtail and further curtail School Fee Bills for all of you as detailed below :-

**a) Bills for 2<sup>nd</sup> Quarter of 2020-21 for all the Classes shall be collected as per rate of Fees existing for the respective Classes in the previous Session 2019-20 i.e. without any enhancement – just as allowed in the current year 1<sup>st</sup> Quarter**

**b) Importantly, the undernoted major waivers are also being introduced for this 2<sup>nd</sup> Quarter :**

**i) Full Waiver of Co-Curricular Activity Fee for all Classes**

**ii) Full Waiver of Stationery Fee for all Classes**

**iii) 50% Waiver of Exam Fee for all Classes**

**iv) 50% Waiver of Tech & Computer Fee for all Classes**

**c) Further, all the Waivers allowed as in (b) above shall also be applicable retrospectively for the 1<sup>st</sup> Quarter of this Session 2020-21.**

**All payments made by Parents for the 1<sup>st</sup> Quarter resultantly in excess of the now specially relaxed Fee Structure for Quarters I and II as elaborated above, shall be suitably adjusted in full against amounts payable for 2<sup>nd</sup> Quarter onwards during the current Session and accordingly Bills for net payable amounts shall be raised. No Bill shall be raised where no net amount becomes due to be paid in the 2<sup>nd</sup> Quarter.**

*Appropriate Fee Bills for those requiring payment shall shortly be available on the eazypay.icicibank.com platform, for online payment as usual.*
