ANNUAL CUBS & BULBULS TRIP FOR CLASSES IV & V

Dear Parents,

A trip for **CUBS & BULBULS** under the auspices of 'Bharat Scouts & Guides' to **TAKI** was in the process of being organized for Classes IV & V Students from 22nd to 24th September, 2024 (refer School circular no. Cir./2024-25/16, Dated July 24, 2024), as the School traditionally encourages it as an essential and compulsory part of the training of the young Scouts and Guides, being a unique opportunity to experience camping and related activities essential for Personality Development and Social Awareness.

A large number of students subscribed, as usual, depositing cheques towards the TAKI tour cost. However, of late a good number of parents have expressed their present concern about the particular venue and in response, the School Management has decided to change the venue to **MANDARMONI**, instead of TAKI. The trip has to now commence on 21st September, 2024 (instead of 22nd September, 2024) and end on 24th September, 2024, consequently costing Rs. 14,000/- (instead of Rs. 12,500/- in case of the TAKI trip, now cancelled) per Student.

Parents who have already paid Rs. 12,500/- (for the now cancelled TAKI trip) are requested to kindly deposit the difference amount of Rs. 1,500/- by cheque drawn in favour of '**Lakshmipat Singhania Academy**' on or before **2nd September, 2024**.

Students who had earlier not opted for the proposed TAKI trip but would now like to participate in the **MANDARMONI** one, are also welcome. Their cheques favouring 'Lakshmipat Singhania Academy' for **Rs. 14,000/-** (total cost of transportation, accommodation, meal charges only) should reach the HRT on or before 2nd September, 2024.

The tour is being conducted entirely by tour operator **M/s. TRAVEL INDIA**.

Should any unavoidable circumstance arise, and cancellation is required by the Parent, a letter should be received by the school, on or before **Monday, September 9th, 2024** which will allow upto **50%** of the tour charges to be refunded. Beyond this date **NO REFUND** can be allowed.
