5. 10 (ten percent) of the new admission in the school in each academic year will be allowed on the recommendation of the School Education Department and 50% of such students will have to be allowed to prosecute studies in the school free of any cost;

6. The school shall have to furnish accurate and up-to-date statistical information relating to the functioning of the school and its academic activities as and when the same is called for by the Deputy Director of School Education(AIS), West Bengal.

7. Violation of any of the conditions laid down in sub-para (2), (3), (4),(5) and (6) shall entail withdrawal of the 'No objection' of the State Govt. with effect from the beginning of the academic year next to that in which the violation is committed.
